DIRECTIONS FOR USE:

1. Please make sure that each newborn lamb receives colostrums at 50 ml per kg bodyweight within the first hour of birth and again in another three equal meals within 24 hours (total 700 ml for a 3.5 kg newborn lamb).
2. Mix Lil' Mary's lamb Milk Replacer with warm water (36-39C) at the rate of 190 g per litre of solution (milk replacer + water). Consult the following table for the amount of milk replacer solution to be mixed up and fed per feeding.

Age	Daily Volume	Volume/Feeding	Feeding/Day
Day 1 (colostrums)	700 ml	175 ml	4
Day 4-7 (1 week)	500 ml	170 ml	3
Day 8-14 (2 weeks)	1000 ml	333 ml	3
Day 15-21 (3 weeks)	1400 ml	700 ml	2
Week 4 - weaning	1700 ml	850 ml	2

3. This table serves as a guideline only and can be adjusted to help meet the nutritional requirements of pre-weaned lambs of various bodyweights or growth rates.
4. Infant lambs should be fed warm liquid feed during the first 2-3 weeks of life, cold milk can be offered afterwards.
5. Introduce a Matrix 18% lamb starter ration to calves of 2 weeks of age. Provide extra water at all times.
6. Lambs can be weaned off milk replacer at about 30 days of age and at least 9-10 kg. They should be eating the lamb starter well (250-450 g). For best results feed 0.5 litre of milk replacer solution once daily during the last week of milk feeding. They should also have a source of free-choice fresh clean water.
