### MILK REPLACER FOR PIGLETS FROM 3 TO 21 DAYS OLD

A list of ingredients may be obtained from the manufacturer or registrant. This feed contains added selenium at a level of 0.30 mg/kg.

# **GENERAL INFORMATION:**

- Mix fresh daily and thoroughly clean and sanitize all milk dispensing and mixing equipment after each use.
- 2. Close partially used bags tightly after each use to maintain freshness of product.

#### MIXING AND FEEDING INSTRUCTIONS:

Mix at a rate of 1.0 kg of Mighty Milk powder with 7.5 liters of warm water (0.133 kg/L).

Leave the piglets with the sow for at least 2-3 days after farrowing to ensure proper intake of colostrum from the sow. Colostrum contains immune stimulants necessary for the piglets' ability to survive and thrive in the barn environment.

After 8 to 21 days of age, always offer fresh creep feed and water when hand feeding by bottle. If a nutritional scours develops, reduce the concentration of the solution by 25-50% but maintain the amount of milk replacer being fed. Continue to feed at this level for 1-2 days then gradually increase back to full concentration. If necessary, provide electrolytes.

Orphaned or runt pigs should be provided with a warm, draft free and sanitary environment to ensure continued survival.
